# National Coal Council 2010 Spring Meeting Summary of Meeting

May 21, 2010

The National Coal Council convened for its spring meeting at the Fairmont Hotel in Washington, D.C., commencing on May 21, 2010, at 9:00 a.m. ET.

## Welcome and Call to Order

At 9:00 a.m. NCC Chair Michael Mueller welcomed attendees, finalized the agenda, and recognized new National Coal Council members. Next, he introduced Assistant Secretary James Markowsky.

#### Assistant Secretary James Markowsky, U.S. Department of Energy

James Markowsky discussed challenges facing coal, some of the efforts underway in the coal area, the FY 2011 energy budget, the Clean Coal Power Initiative Round 3 Program, a recent CCS Solicitation which included large-scale demonstrations of CCS on industrial-type facilities and beneficial reuse of CO<sub>2</sub>, R&D efforts focused on increasing the power plant efficiency, and put forth novel and advanced technologies in the pipeline which will be key to achieving the cost-effective commercial demonstrations, a CO<sub>2</sub> injection and storage program which is finishing up Phase II, and the CCS Task Force.

#### Walter Crickmer, President, Crickmer Company, LLC

Walter Crickmer gave a presentation on Biomass/Coal Blending to Generate Electricity.

## **Finance Report**

Joe Hopf, Committee Chair, spearheaded a motion to accept the audit report for 2009.

#### Secretary's Report

Larry Grimes, NCC Secretary gave a presentation detailing the history, organization (including National Coal Council, Inc.), and public scrutiny of comments.

### **Election of Officers for 2010/2011 Term**

Bob Beck gave the Nominating Committee Report and conducted the Election of the Council Officers for the 2010-2011 term. Joe Hopf, Jr. was selected as Chairman, and John Eaves was selected as Vice Chairman.

## Roger Bezdek, President, MISI

Roger Bezdek began by stating that there has been a lot of talk recently about green transmission lines which would move electricity generated from renewable sources to load centers in the East and West Coasts.

He questioned the political and economic feasibility of such an endeavor.

He summarized that if coal power plants were able to access the new lines, they could cheaply increase output with no additional greenhouse gas emissions.

## **New Study Announcement**

Bob Beck spoke briefly about a new study proposed by the NCC that will review technologies available relative to carbon capture & storage.

#### **Public Comment**

Mark Kresowski, the Corporate Accountability and Finance Representative for the Sierra Club's Beyond Coal Campaign spoke briefly asking that the NCC provide information to the DOE that promotes coal projects — such as carbon capture research — that would promote cleaner energy without passing costs on to citizens through high electric costs. Joe Hopf gave a brief response and rebuttal.
