# November 1, 2013

## WELCOME

John Eaves provided the Welcome Address to the group. He welcomed the Deputy Administrator of the Energy Information Administration, Howard Gruenspecht as well as Peter Davidson, the Executive Director of DOE's Loan Program Office.
