2016 ANNUAL FALL MEETING

SUMMARY OF MEETING

October 5, 2016

The National Coal Council convened for its annual Fall meeting, which was held pursuant to Notice and Invitation at Hilton Milwaukee City Center, 509 West Wisconsin Avenue, Milwaukee, Wisconsin, USA, commencing on October 5, 2016, at 8:15 a.m. CT.

WELCOME

Mike Durham called the National Coal Council meeting to order and provided the Welcome Address to the group. He introduced a number of representatives from the Department of Energy (DOE) in attendance at the meeting, He listed other speakers who will be speaking at the meeting along with the titles of their presentations. He also noted that the program will conclude with Council Business Reports.

He noted that the meeting is being held in accordance with the Federal Advisory Committee Act (FACA), and the Regulations that govern that Act. The meeting is open to the public. Guests from the public will have the opportunity to make comments at the end of the meeting.

He noted that a verbatim transcript of the meeting is being made, and therefore, it is important to use the microphone, and begin by stating name and affiliation.

Mike Durham asked for a motion to adopt the agenda. Ram Narula provided the first motion; Nancy Mohn provided the second motion. All in favor. No opposed.

ANTITRUST ADVISORY

Julia d'Hemecourt of Hunton & Williams provided the Antitrust Advisory via conference call. She noted that the NCC is a Federal Advisory Committee to the Secretary of Energy, and membership confers no immunity from federal or state antitrust laws. The NCC has a set of general antitrust guidelines, and a copy of the general understanding can be sent to members. The meeting will abide by the guidelines. If a member has strayed, there will be an interruption and legal counsel will be sought.

U.S. DEPARTMENT OF ENERGY KEYNOTE PRESENTATION

Dr. Darren Mollot provided the first keynote presentation on Carbon Capture Utilization and Storage (CCUS) on behalf of the Department. He pointed out that working with international partners is important and new technologies are needed. He also mentioned about the Office of Fossil Energy's goals and priorities, including smaller modular systems and domestic and international partnerships. Dr. Mollot covered the technologies that are available for CCUS during his presentation.

Janet Gellici called for questions and there were two questions received from Bill Elliot and Ram Narula for Dr. Mollot.

INDUSTRY KEYNOTE PRESENTATION

Tom Metcalfe provided the second keynote presentation on We Energies' coal units on behalf of the organization. Janet Gellici opened the floor for questions. Two questions were received and answered

Janet Gellici went over the housekeeping items regarding the tour prior to releasing attendees for break.

INDUSTRY PRESENTATIONS: VALUE-ADDED OPPORTUNITIES FOR COAL

Peter Kirk, the Executive Business Operations of NeuCo, a G.E. Company, gave the first industry presentation on "Digital Power Plant Management: Enhancing Coal Plant Environmental Compliance". Janet Gellici opened the floor for questions. Two questions were received and answered.

William Sawyer, the Manager of Hibbard Renewable Energy Center at Minnesota Power/ALLETE gave the second industry presentation on "Carbon-eliminating Allam Cycle for Coal Power Plants." Janet Gellici opened the floor for questions and directed a question to Sawyer. No other questions were received.

Danny Gray, the Executive Vice President of Government & Environmental Affairs at Charah, Inc. gave the last industry presentation on "Beneficial Uses of Coal and Coal Byproducts: Coal Ash & Rare Earth Elements." Janet Gellici opened the floor for questions. Three questions were received and answered.

NATIONAL COAL COUNCIL BUSINESS REPORTS:

Greg Workman, NCC Inc. Finance Committee Chair and Vice-Chair provided the Finance Committee Report.

Deck Sloan, the NCC's Coal Policy Committee Chair was not able to join. Janet Gellici presented on behalf of Mr. Sloan. The Fossil Forward Study was conducted in January of 2015, and the primary recommendation out of that report was on the need for policy parity.

Lisa Bradley, the NCC's Communications Committee Chair was not able to join. Janet Gellici presented on behalf of Ms. Bradley. She mentioned that they have participated in some Congressional Hearings in which some of the results were presented.

Janet Gellici stated that there are no Governance Issues to report.

PUBLIC COMMENT PERIOD

In compliance with FACA requirements for this meeting, Janet Gellici noted that this meeting is duly authorized and publicized, and is open to the public. The public can submit comments to the Department of Energy, or if the individual wishes to speak, they may do so at this meeting.

No comments were made.
